B. Items not on the Agenda: Mrs. Melissa Bufford shared her family is happy to attend Discovery Charter even though having to take her two children to two different schools because her Kindergarten student did not make the DI program this school year. She asked the Board to reconsider the admission process and remedy these type of situations to keep the families together for the Dual Immersion program.

V. Principal's Report

- Mr. MacGaffey shared that the new change of schedule reduced tardies by 50% and is also helping with traffic flow.
- A major focus quarter one will be Social Emotional well being of the students. Discovery is partnering with Sanford Harmony/Fidelity and the PBS Committee to implement a multi-tiered system to achieve a silver ranking for Discovery.
- The new behavior policy is to encourage students when they do well. We are noticing a change on campus with these implementations. We are using tickets, and students with the most tickets get to have lunch with the principal.
- Administration is having individual meetings with families to discuss their critical attendance and Independent Study contracts.
- Mr. MacGaffey shared the school is including all grades to do morning announcements in English and Spanish.
- Principal shared he does classroom observations on a daily basis and invited Board members to participate.
- Discovery started a newspaper club sponsored by 5th grade teacher Mr. dePedro.
- The ILT team had their first meeting and soon will collaborate with the rest of staff.

VI. Dual Immersion/CABE Presentation

Dual Immersion teachers Luz Baeza, Claudia Hernandez and Associate Principal Nestor Espinoza shared their learning from this summer's CABE Dual Language Institute. Both administrators and teachers attended sessions that were specifically geared to the language in which they taught. Administrators learned the latest information on the California Spanish Assessment. Spanish teachers learned how to look closely at the Guided Principals of Dual Immersion. English teachers learned "bridging" strategies to help elevate the Spanish and build awareness of similarities between the two languages. This year the DI team of teachers and administrators will work together during vertical grade level meetings to implement their new learning in all dual immersion classrooms.
