- Principal shared a power point presentation of DCS middle school current and new programs for the 2020-21 school year.

A. Approve Travel to 2020 Early Years Conference

Dates: March 6th-7th, 2020
Location: San Diego, CA
Funding Source: Discovery Preschool
Rationale: This conference will offer educational development strands for Integrating STEAM into the early childhood education setting.
Cost: Registration \$265.00 per participant. Two Discovery preschool permit teachers will attend. Total registration costs \$530.00, not to exceed.

B. Approve change to the DCS Preschool Permit Teachers current Daily Salary Rate to match the current Daily Salary Rate of CVESD Permit Teachers

Rationale: The Discovery Charter Board desires Discovery Preschool Permit teachers be paid at the same daily rate as CVESD Permit Teachers. This change is one-time only in 2019-20.

Effective Date: July 1st, 2019 **Estimated Cost:** \$12,600.00, including associated increase to benefits **Funding Source:** DCS Preschool

C. Approve one additional day on Independent Contractor Agreement with Ro Health, Inc. for Certified Registered Nurse (CRN) Services

Dates: February 20th, 2020 **Location:** Discovery Charter School

Funding Source: Charter General Fund

Rationale: Two days of services from Ro Health, Inc. were already approved, and services were provided, to conduct scheduled hearing tests for Special Education assessments, and for students in PreK, Kinder, 2nd, 5th, and 8th grades. Due to the large number of students in the five grade levels, an additional day is needed to complete testing for the 2019-20 school year.

Cost: \$63.94 per hour, six hours per day, for one additional day. Total expected cost is \$383.64, not to exceed \$450.00.

Description of Services: Full day collaboration with Dual Immersion staff to analyze and vertically align the Common Core state standards in Spanish and English; analyze and compare best practices including GLAD in Spanish; coach teachers on identification of text/genre in English and Spanish.

Cost: \$660.00 for full day collaboration and coaching
