V. Principal's Report

- Congratulated each member of the Odyssey of the Mind for sharing their experience and their very successful performance during the 2021 OoTM Worlds in Miami, FL.
- Thanked all staff for always willing to do whatever is needed, whether it's in their job description or not.
- Dr. Escobedo's last campus visit will be tomorrow and we will wish him well on his retirement this Friday, August 13.
- Ms. Carroll and the new district's coordinators in math, science and VAPA came to see our school program and walk through some of the Fine Arts classrooms.
- Unfortunately, we've had 8 Covid cases since the start of the school year. There appears to be no connection between them (originated off campus). As a result, we have many students on an independent study contract.
- DCS is at #1 on the attendance rate for all the schools in the district.
- DCS is looking at students' writing assessments and data to determine the groups that teachers will establish and work in small groups.
- New partnership with Athlead is going really well. We have three P.E. classes with Athlead working side by side with DCS PE teacher Mrs. Mack.
- Morning drop off and afternoon pick up has gone smoothly.
- DCS Administration started classroom observations and are seeing students learning their routines and procedures. Lots of learning and engagement going on within the classroom.
- Nurse Anabel is doing a phenomenal job handling Covid case requirements and helping students on a daily basis.
- DCS hired a school counselor and five first grade aides who will be starting as soon as they are processed by HR. We also hired 3 new RtI aides and we are looking forward to having the additional support.
- PTC is having a fundraiser at Nuyo ice cream tonight until 8:00 o'clock. Join us!

X. Approve Temporary Increase of Daily Rates for Certificated Substitute Employees

BACKGROUND INFORMATION:

In order to increase the pool of available certificated substitutes during in-person instruction, the DCS requests a temporary increase to substitute daily rates for regular-term and long-term certificated substitute employees. This increase would be effective August 5, 2021, and conclude at the end of the school year, June 3, 2022.

Discovery Charter School also requests temporary approval for site substitutes be assigned daily to address unfilled certificated assignments. The site substitute positions would start August 9, 2021 and conclude at the end of the school year June 3, 2022.

FISCAL IMPACT/FUNDING SOURCE:

Proposed daily rate increases are as follows. The cost will be paid from the state federal COVID-19 Relief funds.
